Such training is provided through approved training and examination centers and FSMQC being one of its approved training providers.

It is imperative for Food handlers enrolling for the EFST program to undergo a 6 to 7 hours training course, who will be issued with a Record of Attendance.

Subsequently, Trainees will be required to appear for a short multi-choice examination through the approved Examination Centre. Successful trainees will receive an Essential Food Safety Training Certificate, valid for a period of 5 years.

These preventive control systems with documentation and verification are recognized widely by scientific authorities and international organizations as the most effective approach towards producing safe food. Further it also enables the producers, processors, distributors, exporters of food products to effectively and efficiently utilize technical resources for assuring complete food safety.

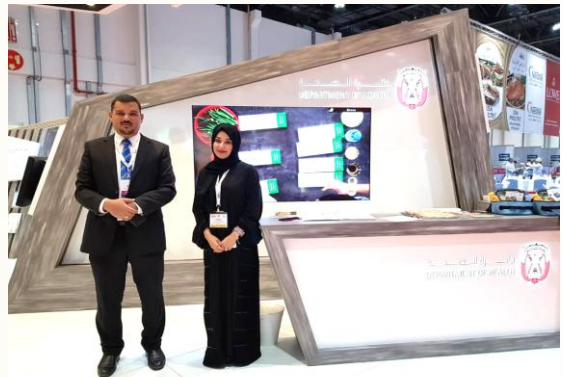
